Rushton Water Recycling centre

We are investing £850,000 into upgrading our existing water recycling centre off Manor Road; installing new equipment and strengthening the current water treatment process. Through the addition of a new dosing tank, kiosk and additional pipework, we will increase the life span of the site and further protect our environment.

This means that our construction team will be working in your area over the upcoming months; starting with site set up at the end of February and lasting for approximately 4 months.

Things you need to know

How will this impact me during site set up?

In the first week, we will be setting up site. This means you may notice a higher volume of vehicle movements while we get equipment to and from site.

We will be setting up our temporary compound in private land outside of our water treatment works. Please see the below illustration for this location.

This will consist of a single stacked cabin which our site team will work from. You may also notice our vehicles parked here. All other machinery and equipment will be kept within our water treatment works.

How will this impact me during construction?

As this work is taking place within our existing site, we expect disruption to you and your neighbours to be minimal.

To access both our temporary site compound and our water treatment works, our vehicles will cross a pedestrian public right of way. Please see illustration found on the website below for further details.

While we are working in the area, these will remain open. Signage will be in place in advance of the walking route. However, we kindly ask residents to stay alert when using these sections of footpath and thank you in advance for your understanding.

There will be a higher number of vehicles, along Manor road, However, dates of key deliveries, will be communicated in good time to help facilitate the deliveries and to minimise the impact.

What hours will your team be working?

Our working hours will vary but we won't start before 07:00am and will always aim to be finished by 17:30pm. There may be occasional weekend working between the hours of 08:00 and 13:00.

How will this affect my water supply?

There are no planned interruptions to your water supply during our works.

Why are we doing this work?

We are required by the environment agency to meet a standard level of overflow water for all our sites. This is just one of many projects that demonstrates our commitment to reduce flooding and being environmental custodians.

Because we invest millions in used water treatment processes such as this one, our river water is the cleanest it's been since the industrial revolution. Nearly 90% of our region's bathing water beaches have 'Excellent' or 'Good' water quality.
